

MARKET SURVEY FOR TRANSPORT OF RDF/SRF TO RECOVERY FACILITIES - CER 19.12.10 - YEAR 2019. Rif. art. 36 c. 7 D.Lgs. 50/2016 s.m.i. and guideline ANAC n. 4 punto 5.1.

(NOTE: THE SOLE PURPOSE OF THIS NOTICE IS A MARKET SURVEY AND IT DOES NOT CONSTITUTE THE START OF A TENDERING PROCEDURE. THE MARKET SURVEY, LAUNCHED BY PUBLISHING THIS NOTICE ON THE OFFICIAL INSTITUTION WEBSITE AND THROUGH THE OTHER EXPECTED MEANS, SHALL BE CONCLUDED UPON RECEPTION AND RETENTION OF THE SUBMITTED APPLICATIONS).

Art.1 — Subject matter and purpose of the notice

Eco Sinergie, through issuing of this notice, wishes to carry out a market survey aimed at identifying the best market conditions available for "transport of RDF/SRF to recovery facilities (CER 19.12.10) in Italy and abroad" from its plant located in Via Clauzetto, 42 - 33078 San Vito al Tagliamento (Pordenone) - Italy.

Art.2 - Persons admitted to bid

Only the companies meeting the following requirements can express their interest:

- are not in one of the situations of exclusion pursuant to art. 80 of Italian Legislative Decree 50/2016 as amended;
- are registered in the Companies Register of the relevant Regional Chamber of Commerce, Industry, Craft Trades and Agriculture (for Italian operators);
- are registered in the Italian Register of Environmental Managers. (Albo Nazionale Gestori Ambientali)
- right to freedom of circulation within the European Community
- a suitable insurance coverage
- furthermore, in case of foreign carriers, they will also need to meet the requirements in force in their respective Countries.

In order to carry out the Service, each company must be equipped with vehicles with <u>walking floor</u> suitable to regularly carry out the requested activities, and all the current authorization concerning waste and transport.

The **quantity to be transported** from the plant is **approx. 20.000 tons**; this quantity is purely indicative and may vary.

The quantity detailed above will be divided between the following recovery facilities:

Route 1) - Quantity of Ton 10.000 destination: Klein St. Paul (9373), Austria, for a total of 217 km of which ton 2.000 from 01/01 to 31/03 and from 01/12 to 31/12/2019

ton 8.000 from 01/04 to 30/11/2019

Route 2) - Quantity of Ton 2.000 destination: Brescia, for a total of 253 km

(from 01/01 to 31/03 and from 01/12 to 31/12/2019)

Route 3) - Destination: Bergamo, for a total of 297 km (quantity enclosed in route 4)

Route 4) - Quantity of Ton 8.000 destination: Parona (PV), for a total of 395 km of which

ton 4.000 from 01/01 to 31/03 and from 01/12 to 31/12/2019

ton 4.000 from 01/04 to 30/11/2019

The **indicative pick-up times** at the Eco Sinergie plant in Via Clauzetto 42 a San Vito al Tagliamento (Pordenone) are the following:

- Monday thru Friday (7:30 AM -noon/1 PM - 4 PM)

Any variations to these times will be promptly notified by Eco Sinergie in writing.

The transport **schedule** must be confirmed within Wednesday of the week preceding the service.

The **minimum weekly availability** for each route must be:

Route 1) -2

Route 2) - 2

Route 3) - 1

Route 4) - 2

The supplier must guarantee constant availability to Eco Sinergie, including in case of force majeure (at the production or destination facility), in which the previously scheduled service must be cancelled or increased.

In compliance with current regulations, the **maximum quantities that can be transported** in each trip are the following:

- Italy: approx. 30 t - Abroad: approx. 24 t

The quantity of waste and the related number of trips are purely indicative and not binding for Eco Sinergie.

Art. 3 Content of the offer

The offer attached to the expression of interest must include:

- price per ton of transported waste;
- number of guaranteed trips per week and month

any other cost pertaining to the service related to each route.

The offer can include one or more routes.

The items indicated above shall be used to identify all the possible scenarios and identify the best solution in order to guarantee to Eco Sinergie a continuous and convenient service, without prejudice to the limitations set forth by current (contract and environmental) laws.

Art. 4 Public tender

After reception of the expressions of interest, Eco Sinergie Scarl shall submit, via certified email/MAIL, the appointment letter, where the documents attesting the requirements and should be request a guarantee policy for the quantity of trips and prices offered will be requested.

Art. 5 Validity, procedures and times to submit the expressions of interest and offers

The parties meeting the requirements above, may express interest by submitting a special <u>declaration</u> and offer according to the form contained in ANNEX 1, made and signed by the legal representative, on unstamped paper, with attached a <u>copy of the ID of the subscriber</u>, pursuant to articles 46 and 47 of DPR no. 445/2000, via mail or other suitable means (carrier or authorized agency), certified mail <u>ecosinergie@gigapec.it</u>, mail <u>info@ecosinergie.it</u>, fax +39 0434-857545, or by direct hand delivery, at the address Clauzetto 42, 33078 San Vito al Tagliamento (Pordenone), <u>before noon of 19 December 2018</u>.

The expression of interest mail or envelope must include the following lettering: "Partecipazione ad indagine di mercato per trasporto di CDR/CSS (CER 19 12 10) a impianti di recupero – ANNO 2019".

The bidder is responsible for a timely delivery of the envelope; Eco Sinergie Scarl shall not be liable for any delay in the delivery of the envelope, due to any reason.

The offer submitted shall be valid for 90 consequent days.

Art.6 Clarifications and Contacts

This notice, aimed at carrying out a market survey, <u>does not constitute an actual contractual offer and does not bind Eco Sinergie Scarl in any way</u>.

The Administration reserves the right to suspend the procedure at any time at its own discretion, and the participants shall not be entitled to lay any claim.

Following this survey, should Eco Sinergie deem to entrust the service to the best bidder(s), the related contracts shall be subject to the issuance of all the legal documents and to all the related inspection of the AVCPASS system in the ANTICORRUZIONE portal (link for new registrations: https://www2.anticorruzione.it/idp-sig/.

In case of non-compliance with the number of trips offered, the successful tendered, based on the contract provisions, may be subject to penalties up to 20% of the cost of the non-compliant service.

For the purpose of compliance with the **professional suitability requirements**, if the bidders are resident in other Member State, they must submit proof of their registration, according to the provisions in force in the Member State, to a professional or trade Register, pursuant to **Annex XVI** (see annex), through a sworn declaration, or according to the procedures in force in the Member State, or by attesting, under their own responsibility, that the certificate submitted has been issued by one of the professional or trade Register of the Member State.

In public tenders, if the bidders or applicants must possess a special authorization, the contracting plant can request proof of this authorization.

Pursuant to Legislative Decree no. 196/2003 and subsequent amendments, data processing will be conducted to safeguard the applicants' rights in accordance with the principles of correctness, lawfulness and transparency.
