



MARKET SURVEY FOR THE SHIP OF RDF/SRF - CER 19.12.10 - to recovery facilities - YEAR 2018
Rif. art. 36 c. 7 D.IGs. 50/2016 and guideline ANAC n. 4 punto 4.1.

(NOTE: THE SOLE PURPOSE OF THIS NOTICE IS A MARKET SURVEY AND IT DOES NOT CONSTITUTE THE START OF A TENDERING PROCEDURE. THE MARKET SURVEY, LAUNCHED BY PUBLISHING THIS NOTICE ON THE OFFICIAL INSTITUTION WEBSITE AND THROUGH THE OTHER EXPECTED MEANS, SHALL BE CONCLUDED UPON RECEPTION AND RETENTION OF THE SUBMITTED APPLICATIONS).

Art.1 – Subject matter and purpose of the notice

Eco Sinergie, through issuing of this notice, wishes to carry out a market survey aimed at identifying the best available market conditions for **“the recovery of RDF/SRF and possible EX-WORKS transport” (Solid secondary fuel CER 19.12.10)** produced in its plant located at Via Clauzetto, 42 - 33078 San Vito al Tagliamento (Pordenone) - Italy

“Recovery” means the operations indicated in Annex C, TITLE I of the fourth section “Recovery operations” of Legislative Decree 152/2006, (subsequently replaced by article 39, par. 5, of Italian Legislative Decree no. 205 of 2010), with reference to R1 Use (main use as fuel or other means to generate energy).

Art.2 - Persons admitted to bid

Only the companies meeting the following requirements can express their interest:

- are not in one of the situations of exclusion pursuant to art. 80 of Italian Legislative Decree 50/2016;
- are registered in the Companies Register of the relevant Regional Chamber of Commerce, Industry, Craft Trades and Agriculture (for Italian operators);
- are duly authorized to recover the materials (Legislative Decree 152/06), or the recovery facilities have a suitable Authorization to recover the material (Legislative Decree 152/06), if applicable;
- are registered in the Italian Register of Environmental Managers for CER 19.12.10 transport, or the third-party providers are registered in the Italian Register of Environmental Managers for CER 19.12.10 transport, if applicable;
- are registered in the Italian Register of Environmental Managers, category 8 “brokering and trade of waste without detention of the same” (for Italian operators), if applicable.

The public tender is open to all economic operators, pursuant to article 3, par. 1, letter p) of Legislative Decree 50/2016, as well as to all economic operators established in Member States, constituted under the law of a Member State.

The companies under liquidation status or subject to collective insolvency or termination procedures are not admitted to the tender.

Art. 3 – Requirements, characteristic properties of the waste, of the service and quantity

The essential requirement to submit an offer is the ownership **of a recovery facility** (cement plant, thermal power station, waste-to-energy plant, etc...) or the **existence of a valid contract** with the indicated recovery plant.

The yearly quantity produced by Eco Sinergie on the basis of historical data amount to approximately **50,000 tons**: this quantity is only approximate and may vary.

The **minimum availability** must be equal to **2,000 tons** per period.

The plant produces RDF/SRF in compliance with national and European standards, including UNI EN 9903, which sets forth a classification system and a scheme to define RDF/SRF properties.

The waste treated by Eco Sinergie is shredded and reduced until it reaches a **fluff size** of approximately **4 x 4 cm with an average 20% tolerance**. If the applicant wishes to submit different prices with a different waste size, these data shall be indicated in the offer form (Annex 1). In compliance with the applicable laws, the **maximum quantities that can be transported** per trip are the following:

- Italy: approx. 30 tons
- Abroad: approx. 24 tons

Art. 4 Content of the offers

The interested parties can submit their offer divided into two yearly periods:

Winter period, from January 1 to March 31 and from December 1 to December 31;

Summer period, from April 1 to November 30.

The interested parties can submit both offers or just one, and can exclude intervals of each period (example: summer period except for August).

In the offers of market survey (**ANNEX 1 for winter period, ANNEX 2 for summer period**) must include:

- location of the recovery plant(s) authorized to receive the RDF/SRF waste
- recovery price per ton for each period (for 4x4 cm waste size, with an average 20% tolerance)
- the available quantity in tons (minimum availability per period 2.000 tons)

- the availability to collect the RDF/SRF EX-WORKS from the facility located at Via Clauzetto 42, San Vito al Tagliamento (Pordenone) - Italy, and the price per ton (transport);
- no. of minimum weekly and period trips:
 - no. 4 for every 2000 tons, for the winter period
 - no. 2 for every 2000 tons, for the summer period
- plant's periods of closure (with indication of a possible alternative plant, to guarantee continuity of the service);
- other waste sizes (cm) and €/ton

The entrustment to each contractor may include:

- one or two periods;
- treatment only
- treatment + transport.

The items indicated above shall be used to identify all the possible scenarios and identify the best solution in order to guarantee to Eco Sinergie a continuous and convenient service, from an economic and logistical point of view, without prejudice to the limitations set forth by current (contract and environmental) laws.

Art.5 Public tender

After reception of the expressions of interest, Eco Sinergie Scarl shall submit, via certified email/MAIL, the appointment letter, where the documents attesting the requirements and a guarantee policy for the quantity of trips and prices offered will be requested.

Art.6 Validity, procedures and times to submit the offers of market survey

The interested parties meeting the requirements above, may express their interest by submitting a special declaration and offer according to the forms contained in ANNEX 1 and/or ANNEX 2, made and signed by the legal representative, on unstamped paper, with attached a copy of the ID of the subscriber, pursuant to articles 46 and 47 of DPR no. 445/2000, and send it in an sealed envelope only **by post mail or other suitable means (carrier or authorized agency), or by direct hand delivery, to the following address: via Clauzetto 42, 33078 San Vito al Tagliamento (PN), peremptorily before noon of 24/10/2017.**

The market survey envelope must include the following lettering: **"Partecipazione ad indagine di mercato per l'invio di CSS a impianti di recupero"**.

The bidder is responsible for a timely delivery of the envelope; Eco Sinergie Scarl shall not be liable for any delay in the delivery of the envelope, due to any reason.

The offer submitted shall be valid for 90 consecutive days.

Art.7 Clarifications and Contacts

This notice, aimed at carrying out a market survey, does not constitute a contractual offer and does not bind Eco Sinergie Scarl in any way.

Eco Sinergie reserves the right to suspend the procedure at any time at its own discretion, and the participants shall not be entitled to lay any claim.

Following this survey, should Eco Sinergie deem to entrust the service to the best bidder(s), the related contracts shall be subject to the issuance of all the legal documents and to all the related inspection of the AVCPASS system in the ANAC portal (link for new registrations: <https://ww2.avcp.it/idp-sig/>).

In case of non-compliance with the number of trips offered, the successful tendered, based on the contract provisions, may be subject to penalties up to 20% of the cost of the non-compliant service.

For the purpose of compliance with the **professional suitability requirements**, if the bidders are resident in other Member State, they must submit proof of their registration, according to the provisions in force in the Member State, to a professional or trade Register, pursuant to **Annex XVI** (see annex), through a sworn declaration, or according to the procedures in force in the Member State, or by attesting, under their own responsibility, that the certificate submitted has been issued by one of the professional or trade Register of the Member State.

In public tenders, if the bidders or applicants must possess a special authorization, the contracting plant can request proof of this authorization.

Pursuant to Legislative Decree no. 196/2003 and subsequent amendments, data processing will be conducted to safeguard the applicants' rights in accordance with the principles of correctness, lawfulness and transparency.
